

We are proud of the work we do on behalf of all Cochise County community members and this is our opportunity to share it with you.



COCHISE COUNTY HEALTH PROFILE Cochise County Geography & Demographics

Cochise County is a rural, agricultural area that straddles the US-México border with two ports of entry in Douglas and Naco. The total county population is 131,694 and 72,357 (55%) live in areas that meet the definition of rural. Cochise County scores 0.93 on the CDC Social Vulnerability Index (SVI) with 1.0 being the most vulnerable. The rural areas rank very high on the Social Vulnerability Index – mostly in the top 4th for each of the four vulnerability themes that represent 15 risk factors.

At one point during the Covid-19 pandemic, Douglas a border community where over 70% of the community identify as Hispanic - had 47% of the confirmed Covid-19 cases in Cochise County but represented only 12.7% of the county population.

One third of Cochise County residents are Hispanic/ Latino. Many first or second generation Mexican Americans and many farmworkers from México are attracted to the area.

Douglas and Willcox residents are 74% and 35% Hispanic/Latino respectively. Nearly one third of county residents speak a language other than English at home, meaning that they lack English Language Proficiency. In the Douglas and Willcox areas, 65% and 30% of residents speak Spanish at home. 26% to 16% of our rural communities live in poverty and 38% to 19% of children under age 12 live in poverty. Limited education is a social determinant in the Douglas, Willcox and Bisbee/Naco areas, where 14% to 7% of adults have less than a 9th grade education.

Unemployment is high across the board, ranging from 30% in Douglas to a low of 11% in Bisbee, which is the county government seat and major source of employment. The percentage of residents without health insurance in 2020 was highest in the Douglas and Willcox areas due a greater number of undocumented Hispanic/Latino residents and migrant farmworkers.

Promoting Healthy Living in All Communities

Health in Arizona Policy Initiative (HAPI)

The goal of the initiative is to increase local capacity to implement preventive health policy, systems and environment changes in defined strategic areas set by the Arizona Department of Health Services. The majority of our work in 2020 has been assisting schools with school/student wellness policies; and assisting communities to address gaps in public health issues.

- Provided wellness policy development assistance to 12 school districts.
- Engaged 21 School Health Wellness Coordinators to coordinate a School Health Advisory Council.
- Assisted 6 worksites through the 2020 Healthy Arizona Worksite Program (HAWP), all of which were awarded either Silver, Gold, or Platinum status:



The school food pantry program is the perfect example of our force multiplier approach. Alone we would have struggled to make a difference addressing childhood food insecurity. By collaborating with Benson Unified School District and Benson Youth Movement we have helped make a real difference.

Chronic Disease Prevention

Our work focuses on prevention efforts directed at the four leading causes of chronic disease deaths – cancer, heart disease, chronic lower respiratory diseases, and Alzheimer's. Evidence based curriculum is delivered to a variety of community groups to



A Finding Meaning and Hope virtual workshop was scheduled for November, 2020, but was cancelled due to lack of enrollment.



Coordinated the annual 2020 Ama Tu Corazon (Love Your Heart) event in Douglas in February where 51 blood pressure screenings were completed:

- 43% were in normal range
- 57% were elevated to varying degrees

In 2020 we piloted **Target BP**, a new prevention strategy, in partnership with the American Heart Association. We located a provider training site at Chiricahua Community Health Center where the strategy will be introduced in 2021. Providers will be trained in **Target BP**, and then they will track BPs of their patients and provide resources to them.

Worksite Fitness Plus - worksite wellness for Cochise County employees

Participation numbers decreased in 2020 due to the COVID-19 pandemic as almost all county employees worked from home from April through September 2020. However, several weeks into the "work from home" status a virtual platform was set-up so that participants could continue with their wellness plan through on-line coaching.

- 16 new participants were added to the program this year, in comparison to 48 new participants in 2019.
- 184 active participants remained in the program. This was only a slight decrease from 2019 and represents almost 25% of the entire Cochise County employee population.

Tobacco and Teen Pregnancy Prevention

Tobacco Prevention and Cessation

Our efforts are focused on reducing tobacco related disparities among adults and youth by education, outreach, and policy advocacy to prevent tobacco use and to bring awareness to other issues such as secondhand smoke and vaping. For adults we provide cessation presentations and resources; and assist worksites in smoke-free policy development. The youth coalition provides peer to peer presentations, participates in retailer compliance checks, and a addresses policy change within our communities. As with many other programs, it has been difficult to meet our goals in 2020 as most groups were not meeting or meeting virtually only, and many of them had higher priorities during this time.

January 2020 - Prevention Services Division staff received Ask, Advise, and Refer training and a How to Identify Vaping Products presentation. February 2020 - We participated in the Palominas School District Employee

Health Fair. **March 2020** - Peppertree Apartments in Douglas was presented with their personalized Smoke-Free recognition poster.



New target populations added in 2020: Low SES Population and Recently Released Inmates. During pilot year FY 20-21 we met with the Public Health Social Worker at our Cochise County Jail, and other internal and community partners to devise a plan that will best suit the recently released inmates. To meet the deliverables of the low SES population strategy we plan to work with internal CHSS programs, Chiricahua Community Health Centers, and Copper Queen Community Medical Associates.

The Youth Coalition maintained 21 consistent youth volunteers, even throughout the COVID-19 pandemic. Beginning in April, 2020 the group met virtually and but did not have an opportunity to provide face to face presentations to their peers or to the Douglas City Council. Other events that have been affected by the pandemic include:

- Retailer Compliance checks - both the Spring and Fall checks were cancelled.

- Arizona Retailer Tobacco Trainings - also cancelled as worksites were not able to fit virtual trainings into their schedule. Successes achieved this year:

Mayoral Candidate Forum hosted virtually in March, 2020 by the Youth Coalition allowed the youth to ask candidates questions about issues affecting their community.

Red Ribbon Week activities included a drive-through event in October 2020, where the community was able to obtain tobacco and drug prevention materials and giveaways. Virtual presentations were also provided to the community by coalition members.

Pamela, 17, a senior at Douglas High School, was one of 10 Arizona students, and the lone Cochise County representative, to be selected to serve on the *National Youth and Young Adult Ambassadors by the Campaign for Tobacco-Free Kids* committee. She has been involved in tobacco control and prevention since her freshman year in high school through the Cochise County Youth Coalition. As an Ambassador, Pamela hopes to build on her strong experience working within her community to educate others on the harms of tobacco and to take her advocacy to the next level by informing decision-makers at the state and federal levels.



Teen Pregnancy Prevention

We offer 8 different evidence-based curriculum to high schools and middle schools to improve the health and social well-being of youth through the reduction of teen pregnancies and sexually transmitted diseases, and the awareness of healthy relationships and life skills.

Due to the Covid-19 pandemic, schools throughout the county were shut down in April, the fall semester began late, and many schools were only providing virtual education to their students. In October students were offered the *Hybrid Model* which allowed students to attend school part-time in the classroom and part-time from home. By the end of November approximately 15 schools from various school districts had gone back to virtual learning only. We offered to conduct our curriculums virtually but challenges included schools that did not have time to meet with us for planning, schools that did not have the IT capacity or platform to allow us to provide our curriculum virtually to their students and students unwilling to spend more time online after they had sat in front of a computer all day for class time.

Services Provided: Evidence-based curriculum education was provided to 364 youth in 4 schools, during January through March, 2020. This was a decrease of 83% from the 2,205 youth in 14 schools who were educated in 2019.



The Arizona Supplemental Nutrition Program for Women, Infants, and Children (WIC) provides nutrition education and breastfeeding support services, supplemental nutritious foods and referrals to various local, state and federal health and social services. WIC serves pregnant, breastfeeding, and postpartum women; infants; and children under the age of five who are determined to be at nutritional risk.

The WIC Program is funded by the United States Department of Agriculture and, in Arizona, is hosted and managed by the Arizona Department of Health Services, Bureau of Nutrition and Physical Activity

Community Outreach – staff performed 137 separate instances in 15 different communities.

On October 15th, we hosted a "COVID-friendly" drive-through outreach event. We provided free nutrition-based resource and incentive items, eligibility screenings, appointments for WIC, and car seat safety checks for 13 families.



Covid-19 Pandemic Response

In the face of the rapidly rising pandemic, beginning in March of 2020 all WIC programs converted to remote/virtual service provision, under a federal USDA waiver of the physical presence requirement. This initiated a great deal of new learning in areas of remote learning, accessibility to technology and increased communication about scheduling, services and managing technology.

Workforce Development

During 2020 we replaced the **WIC Program Manager**, the **WIC Registered Dietitian** and <u>four</u> **Nutrition Education Specialist** positions - a 55% turnover of WIC the team. We were fortunate that 3 of the 4 staff who left gave extended notice and were able to provide overlap services while newly hired staff completed their training.

Partnership with Cochise County Breastfeeding Task Force:

Celebrated World Breastfeeding Week 2020 on August 1-7th via the Task Force's Facebook page:

Increased social media presence on the CCBF Facebook page with the assistance of the local AZ Health Zone, the ADHS IBCLC Consultant and the Cochise WIC Breastfeeding Peer Counselor posting various topics on COVID-19 and breastfeeding.

Offered TOGETHER FOR THE DURATION – series of 15 online lactation courses based on evidence and guidance provided by AAP, CDC, WHO & UNICEF.

Updated and distributed Cochise County Breastfeeding Resources List.





The Health Start Program is funded with Arizona State Lottery funds and is hosted and managed by the Arizona Department of Health Services, Bureau of Women and Children's Services. **Arizona Health Start** is a community based, evidence informed home visiting program that utilizes community health workers to provide education, support and advocacy services to pregnant and postpartum women and families with children up to two years of age. Health Start utilizes the promising practice curriculum *Partners For A Healthy Baby* to educate families.

Family Visitation: Five full-time Community Health Workers (CHW) and one program manager serve families in all Cochise County communities. Each CHW carries a caseload of 20-30 families and provides a minimum of 35-45 visits per month. Topics addressed during home visits include: what to expect during pregnancy, breastfeeding education and support, nutrition for children and pregnant women, child development, home health and safety, community resources, school readiness as well as family centered topics that the parents wish to discuss.

During 2020, 197 families (140 children) received 1,926 visits and 28 children graduated from the program.

COVID-19 pandemic response - In March 2020, we began providing all visits with our families virtually using a variety of technical options including emailing and texting information to families and conducting visits via phone or virtual platform including skype and zoom. Our visit numbers increased as families began reaching out for additional support.

Program Expansion - In February 2020 we were selected by the Arizona Department of Health Services to participate in the Maternal Health Innovation Project (MHIP) to address disparities in maternal health and improve maternal health outcomes. This includes increasing access to prenatal care and completing Post-Birth Warning Signs education with each family during their third trimester of pregnancy and then again immediately following the birth of the baby. Community classes are also implemented focusing on the post birth warning signs for maternal morbidity and mortality, and how to have a healthy pregnancy.

Public Health Nursing

Achievements

In anticipation of storage needs for upcoming Covid-19 vaccines, nursing was able to vastly improve cold chain storage capabilities with the purchase of new refrigeration and freezer units at various sites. A generator was also installed at the Sierra Vista location in the summer of 2020.



Public Health Nurses assisted in the Cochise COVID-19 Pandemic Response efforts, **conducting contact tracing** during June, July, August and September.

Public Health nurses also collaborated with the Detention Medical nurses to **provide Covid-19 testing** for Cochise County Jail staff and inmates.

Covid-19 Antibody Testing Study via the University of Arizona Mel and Enid Zuckerman College of Public Health:



University of Arizona Collaboration

May of 2020 CHSS Nurses collaborated with U of A in State-wide antibody testing. Testing occurred in Douglas and Sierra Vista. The study revealed that as of June 2020, less than 1% of Arizonans had protective antibodies against Covid-19.

Collaboration with Cochise College and other Universities:

- Precepting bridges the gap between classroom learning and clinical practice. Historically CHSS nurses participate in mentoring the future nurses of Cochise county. Due to the pandemic virtual precepting was offered for a local BSN student attending Grand Canyon University.
- Educating future nurses about the roles and responsibilities of public health nursing is accomplished by guest speaking for the Community Health nursing class at Cochise College. This year it was done virtually.



Professional Development

Furthering education allows for nurses to grow and gain competency in their nursing, ultimately leading to optimal care and protection of the public. Congratulations to Lindsey Moses, BSN, RN for completing her Bachelors of Science in Nursing.

Clinic Services were partly suspended due to participation in the Covid-19 pandemic response. During 2020 limited services were still available to the public: (2019 numbers included as a comparison)

Child Care Health Consultant (CCHC)

CCHCs work with child care centers, home based providers and preschools to promote safe and healthy learning environments for young children. 2 consultants provided 151 total visits with 29 child care centers (72 visits were virtual) and 30 virtual training sessions.

Environmental Health Services

Covid-19 made 2020 a challenging year for Environmental Health. With the increasing cases of Covid-19 the department had to re-evaluate how inspections of food establishments were conducted, as we faced a shortage of sanitarians. Several establishments had closed due to the Executive Order and guidance by the State Health Department. During this time Environmental Health staff focused on completing on-line trainings and developing a process to conduct inspections that would reduce their exposure to the virus. During the pandemic inspections did decrease and temporary events were canceled. Towards the end of 2020 Environmental Health began conducting the inspections of on-site wastewater (septic) systems and well application reviews.

Food Protection

The Food Protection Program inspects and permits food service establishments including temporary events, along with investigating possible food borne illness complaints. Cochise County Environmental Health focuses inspections based on the risk factors that are likely to increase the risk of people getting sick. Risk factors include inadequate cooking, food from unsafe sources, improper holding temperatures, contaminated equipment, and poor personal hygiene.

Lodging Facilities and Recreational Facilities

Environmental Health provides health and safety inspections at regulated public facilities including hotels and motels, mobile home & RV Parks, school campus, children's camps, public and semi-public swimming pools and investigates complaints regarding public health nuisances and hazards. *Mandated annual inspections were conducted at:*

On-site Wastewater (Oct 2020-Dec 2020) Private Sewage Permitting and Inspections

Cochise County Environmental Health regulates private sewage systems (Septic Systems). Environmental Health staff members review submitted designs for approval, onsite inspection and final installation inspections to ensure that the systems comply with ADEQ standards. Environmental Health also conducts review of well applications with a well on 5 acres or less to ensure proper setbacks are met.

Public Health Emergency Preparedness (PHEP) The team includes a Coordinator, an Epidemiologist and a Specialist. This program plans for, coordinates and monitors the local public health response to emergencies and hazards across **six domains** outlined by the Centers for Disease Control (CDC):

COMMUNITY RESILIENCE In January 2020 we provided a full-scale exercise on a mass fatality event. Partners included the Cochise County Office of Emergency Management, Fry Fire Department, Sierra Vista Fire Medical, the American Red Cross, and Sierra Vista Unified School District. Multiple agencies and stakeholders worked through the process of patient tracking and location, resource requesting and mobilization, and communication with incident command and the local healthcare system.

INCIDENT MANAGEMENT Throughout 2020 we managed the public health response to the Covid-19 pandemic, including management of subsequent incidents caused by the pandemic, such as hospital surges, death care surges, and mass vaccination events. PHEP mobilized and demobilized a Public Health Emergency Operations Center (PHEOC) and integrated with the Cochise County Office of Emergency Management's Emergency Operations Center (EOC) as needed throughout the incident.

SURGE MANAGEMENT We tracked hospital capacity daily in Cochise County and southern Arizona, and assisted hospitals with supplies and staffing, often advocating on their behalf to the Arizona Department of Health Services. We also developed closer relationships with local funeral directors, which enabled us to receive daily capacity reports so we could mobilize resources for fatality management to handle death surges.

COUNTER MEASURES AND MITIGATION For the Covid-19 response we received, organized, tracked, and distributed supplies from the Strategic National Stockpile, including management of scarce and in-demand resources such as PPE for healthcare partners in our community. We also worked with our healthcare partners to develop a plan and system of ordering, receiving, tracking, and dispensing of vaccines throughout the county. With the assistance of local fire departments, PHEP coordinated both small and large-scale points of dispensing (PODs) for vaccinations.

INFORMATION MANAGEMENT Due to the rapidly changing nature of the Covid-19 pandemic, information sharing was a crucial and challenging focus for PHEP. We established a central website which served as the hub for all Cochise County Covid-19 information and also developed media in the form of flyers, podcasts, and radio PSAs for public consumption. A boots on the ground effort reached out to various health care organizations to expand our distribution group. This proved indispensable when it came to keeping local stakeholders up to date with the changing information and offered a two-way channel for communication. As we moved into vaccine operations, this line of communication allowed for a smooth planning and operations process.

At it's height the website had nearly 3,000 visitors a day.



Public Fiduciary and Area Agency on Aging Case Management

The Area Agency on Aging (AAA) Case Management program is funded by *Southeastern Arizona Governments Organization* (SEAGO) and Cochise County. AAA Case Managers work with community members 60 years and over, their unpaid family caregivers and disabled adults to identify support systems enabling older adults to maintain maximum independence and dignity in their homes and communities. A holistic assessment is completed to determine eligibility for AAA services.

AAA Case Managers served 466 clients and their family caregivers with a total of 5,579 hours of case management in 2020

Case managers authorized over 15,000 hours of SEAGO-funded services:

- 59 hours of housekeeping
- 13,306 hours of attendant care
- 1,758 hours of respite care

During 2020, Public Fiduciary staff also resolved **123 inquiries** by providing information and guidance on less restrictive options to

that of guardianship and conservatorship and/or providing direction

to court self-service resources that do not require a probate filing.

- assistance to qualify for benefits such as the Arizona Long Term Care System
- assistance with utilities
- assistance with pest control

The Public Fiduciary serves as court-appointed guardian, conservator and personal representative of last resort pursuant to Arizona Revised Statutes. Referrals are generated from various sources including the community, hospitals, law enforcement, and Adult Protective Services. A comprehensive investigation of each referral is conducted to determine whether it is appropriate and necessary for the Public Fiduciary to pursue a court appointment as Guardian, Conservator or Personal Representative.

Conservatorship is granted by the court. The court appoints a Conservator who makes decisions regarding the ward's estate. A conservator must file an annual accounting with the court showing a clear record of income and expenses for the ward's estate.

Guardianship is granted by the court after a finding of incapacity is made. The court appoints a Guardian who makes decisions on behalf of the ward to preserve his/her wellbeing. A guardian must file an annual report with the court providing information about the ward's wellbeing and finances if no conservator has been appointed.

Personal Representative - Depending on the value of the decedent's estate, a Personal Representative may be appointed to handle the final affairs and distribution of assets according to the decedent's last will and testament or to the state's intestate laws.

Vital Records

Certified copies of birth and death certificates are provided for persons who are born or who die in Arizona. Applications can be completed on paper and submitted by mail to our Sierra Vista and Bisbee sites or via drop box at all five sites. Applicants can also apply online at the VitalChek website: <u>www.vitalchek.com</u>.

Indigent Burials

Cochise County is committed to providing dignified final arrangements for those who die in Cochise County without the funds to pay for Cremation or Burial: **During 2020 Cochise County paid for 36 cremations & 2 burials.**

- The legal responsibility for final disposition in Arizona generally belongs to the decedent's next of kin. If the next of kin is not financially able to assume the cost, a county indigent burial or cremation may be requested.
- Eligibility for the *Arizona Health Care Cost Containment System* is the basic criterion for eligibility for Cochise County indigent cases. The next of kin will be asked to complete and sign an affidavit affirming their financial status to determine eligibility.
- In accordance with Arizona law, Cochise County reserves the right to recover costs from the decedent's estate. Documentation to recover the county's cremation or burial costs will be filed with any financial institution determined to be in possession of monies in an account in the decedent's name.
- Cochise County typically provides cremation services for indigent cases; however, a burial may be requested if the decedent already possesses a local cemetery plot.
- We work with local funeral homes to provide indigent burials or cremations for veterans at the Southern Arizona Veterans Memorial Cemetery in Sierra Vista.

Medical Examiner

Cochise County maintained its own Medical Examiner (ME) until 2012. When the local ME retired, Cochise County opted to contract with the Pima County Office of Medical Examiner (PCOME).

The PCOME accepts or declines jurisdiction of a case based on circumstances. They will decline jurisdiction if it is a death due to natural causes, and if the decedent was under medical care for any reason or if any medication had been prescribed by a doctor within the preceding 18 months. They also accept jurisdiction for all cases that may be due to non-natural causes: i.e. homicide, suicide, any person who is not identified or if an injury occurred such as a car crash or fall, or if the decedent was not under the medical care of any doctor. The ME is also responsible for cremation authorization. For every cremation requested the ME must approve the request to ensure that there are no communicable diseases and that all causes of death are natural death and not a case that should have fallen into their jurisdiction. In 2020, the PCOME approved 940 cremations and Cochise County transported 172 decedents to the PCOME for jurisdiction.

Title 36 - Arizona Revised Statutes § 36-523

Title 36, Chapter 5, Articles 4 & 5, outlines an involuntary process for evaluation, care and treatment of persons with a mental health disorder. According to A.R.S. §36-523 the Cochise County Attorney's office can file a petition for Court Ordered Evaluation. According to the results of the evaluation, a petition for Court Ordered Treatment can be filed.

At any time during the process, the patient may choose to accept care and treatment voluntarily.

Cochise Health & Social Services Fiscal Responsibilities

The finances of Cochise Health & Social Services (CHSS) are complex, ranging across a variety of programs and services and different funding sources. Each division has fiscal responsibilities that are unique to that division. **CHSS has 7 divisions:** 1.) Prevention Services 2.) Clinical Services 3.) Environmental Health 4.) Public Health Emergency Preparedness and Response 5.) Detention Medical 6.) Public Fiduciary and 7.) Administration, which includes 7a.) Vital Records 7b.) Indigent Burials 7c.) Title 36, and 7d.) Finance.

Source of Funding for CHSS

Many of our divisions enter into Intergovernmental Agreements (IGAs) with the Arizona Department of Health Services (ADHS), the Arizona Health Care Cost Containment System (AHCCCS), the Arizona Department of Environmental Quality (ADEQ), and others. These IGAs are contracts that outline the work we do on behalf of the contractor. Contracts can be reimbursement based or fixed price or fee for service. Detention Medical and Administration are the only two divisions that are funded solely through the General Fund. The general fund represents the revenues the County collects from taxes, and fees for service. Divisions and programs that are funded through the general fund are typically mandated services required by the Arizona Revised Statutes.

Prevention Services has three programs:

- Health Promotion, WIC-Women, Infants and Children, and Health Start.
- Health Promotion has multiple project units that are tasked with specific targeted health related topics.
- Each program and project unit are funded through various Intergovernmental Agreements and contracts.

Clinical Services are similarly complex with multiple funding streams. However, much of the work conducted in the Clinical Services Division is mandated and the Intergovernmental Agreements are meant to supplement general funds rather than cover the full cost of providing the mandated services.

Environmental Health Services are funded through the General Fund and through fees for services. The fees charged are not set at a rate that covers the cost of providing these mandated services therefore, general funds are used to cover the additional cost. Fees collected represent approximately 70% of the cost.

Public Health Emergency Preparedness received considerable additional funding in 2020 due to the Covid-19 pandemic response.


Detention Medical budget covers both the Jail Clinic and the Behavioral and Mental Health care provided to individuals who have been incarcerated in the Cochise County detention center.

Public Fiduciary services are both mandated and grant funded. The mandated portions of our responsibility are covered through general funds.

Medical Examiner services are contracted with the Pima County Medical Examiner to provide theses mandated services. The budget includes the contract for services and the cost of transporting decedents to and from Tucson.

Administration services includes Vital Records, Title 36, Indigent Burial and Finance.

The total 2020 Expense Budget for Cochise Health and Social Services was \$9,329,421.64.
